Happy Holidays,

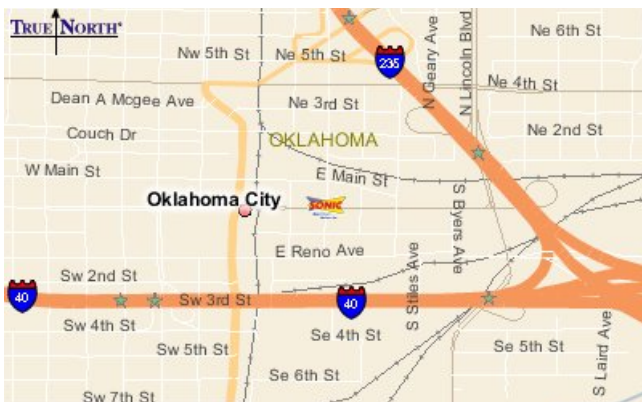
